Presentation: Taghi Ozbeki, Database Administrator, Delaware Valley Regional Planning Commission, "DVRPC Interactive Database: Census 2000 and Traffic Counts."

Taghi Ozbeki gave a report on, and demonstration of, the Census 2000 and Traffic Count interactive databases available through the DVRPC website. These applications were developed by DVRPC as part of the Regional Information Network. Census 2000 population count data for the 9-county region is available at the Minor Civil Division (MCD) level, and can be searched by either county or by municipality. These data can be downloaded in either Excel or ASCII formats. Traffic counts data can be searched by municipality, route name or route number, and can be sorted by municipality, road name, AADT or DVRPC id. # Presentation: Whittona Burrell, Representative, U.S. Census Bureau, "Census Web-Based Files."

Whittona Burrell began her presentation by giving a brief overview of the Redistricting Data (Public Law 94-171) Summary File. Release schedules were discussed, as well ways to access the data. Data is available for a number of states, including Pennsylvania and New Jersey, through the Census website American Fact Finder application, FTP downloads, or through the purchase of a CD-ROM or DVD. Census Bureau will also provide data to the state data centers for distribution. Changes since the 1990 census were addressed, including the expansion of race and ethnicity categories. Whittona indicated that development of the race and ethnicity categories was undertaken by the Office of Management and Budget.
