Enclosed is the Federal Fiscal Year 2012 Second Quarter Progress Report for your region(s). At this time we are operating under authorization legislation through June 30, 2012. Due to the unknown funding levels for the year, the establishment of draft targets was not possible. Once Congress enacts legislation for the full federal fiscal year, targets will be developed for the regions.

The Program Report includes a statewide summation of actual obligations and encumbrances for all of the regions in Pennsylvania. The report also includes an individual Program Report for your region.
