"Transportation Improvement Program: What is it? Why does it matter?"... Kwan Hui, Transportation Planner at DVRPC

Kwan Hui presented on the role of the Transportation Improvement Program (TIP) in DVRPC's work and the importance of the TIP to the region. She highlighted the online tools that allow the public to comment on, interact with, and inform TIP projects. Attendees asked questions after the presentation.

"King of Prussia Rail Project"... Liz Smith, Manager of Long-Range Planning at SEPTA

Liz Smith presented on the development of the possible extension of the Norristown High Speed Line to serve the King of Prussia area, giving background on the development, the need in the area, the project schedule, public participation, recommendations, and next steps. Attendees asked questions after the presentation.
