INTRODUCTION

This resource guide documents national, regional, state, county, and nonprofit funding and technical assistance resources that may be utilized to support the reuse and revitalization of the Paoli Rail Yard site. The resources summarized here were determined by DVRPC staff to be among the most relevant for achieving the vision of a new Paoli Transportation Center.

The resource guide was created to increase awareness about the funding and technical assistance programs available to support the range of planning and development activities targeted for the area. The guide is intended for use by the cooperative agencies and local leadership represented by the Paoli Rail Yard Task Force. In particular, Tredyffrin and Willistown townships are eligible for many of the resources identified in the guide.

The guide is not meant to be an exhaustive listing of all resources available to local government and community group stakeholders in the project vicinity. Rather, it highlights programs designed to provide assistance for the types of planning and development activities

envisioned at the Paoli Rail Yard site. These activities include access and circulation improvements for vehicles, pedestrians, and bicyclists; revitalization of the Paoli business district; and environmental enhancements. Resources are organized by the following four planning areas:

- Smart Growth/Community and Economic Development
 - Transportation and Infrastructure
 - Environment and Recreation
 - Brownfields

SMART GROWTH/COMMUNITY AND ECONOMIC DEVELOPMENT

Program:	Chester County Community Revitalization Program
Form of Assistance:	Reimbursement grant with matching fund requirement. Eligible activities include streetscapes and sewer, water, and stormwater infrastructure with a limit of one activity being funded per year.
Eligibility:	The 15 Boroughs of Chester County and the City of Coatesville.
Terms:	Urban centers are eligible for a maximum reimbursement of 75% of the total project costs up to the maximum grant award, with additional revitalization incentives available to the smallest municipalities with the least affluent populations. Maximum funding amount not to exceed \$1,000,000 a year.
Deadline:	Applicants must have a community revitalization strategic plan in place.

Program:	Community Action Team (CAT)
Form of Assistance:	Planning, technical, and financial assistance, and implementation to create priority "impact" projects through more efficient delivery of state services and program funding.
Eligibility:	Pennsylvania local governments, redevelopment authorities, industrial development agencies, and nonprofits. CAT encourages working with as many stakeholders as possible.
Terms:	The Community Action Team is an all-purpose economic and community development tool for every community. Whether large or small, urban or rural, the Community Action Team will work with, or help develop a community comprehensive plan, and assist with the financing and implementation of that plan. CAT encourages the exploration of all ideas, including the use of tax credits, creating a funding package through the Governor's Action Team, or inter-municipal cooperation.

Form of Assistance:	Grants to support local initiatives that promote community stability and quality of life.
Eligibility:	Pennsylvania local governments, redevelopment authorities, industrial development agencies, and nonprofits.
Terms:	Grant awards are made in three funding rounds during the fiscal year. DCED will grant approximately 1/3 of the program appropriation in each round. Grant applications not funded in a particular round will be considered in future rounds in the same fiscal year.

Form of Assistance:	Grants to encourage conservation planning and sound land use practices.
Eligibility:	Pennsylvania local governments.
Terms:	Grant funding not to exceed 50% of eligible costs for projects that advance conservation or sound land use strategies or practices, either as a stand alone product or as part of comprehensive recreation, park and open space or a municipal plan.
Deadline:	Varies.

Program:	Housing and Redevelopment Assistance			
Form of Assistance:	Grants for community revitalization and economic development. The program provides flexible funding to cities and smaller urban areas to redevelop and reuse blighted and/or vacant property, to expand housing opportunities, to promote neighborhood stability, and to assist in becoming competitive for business retention, expansion, and attraction.			
Eligibility:	Pennsylvania local governments, redevelopment authorities, housing authorities, and nonprofits.			
Terms:	This is the state's most flexible funding stream available to municipalities for community revitalization and economic development. There is no minimum or maximum; typical grants average between \$150,000 and \$200,000. In 2007, \$34 million was allocated for the Housing and Redevelopment Assistance program.

Form of Assistance:	Grant funds for the preparation of community comprehensive plans and the ordinances to implement them.			
Eligibility:	Pennsylvania cities, boroughs, townships, counties, or multi-municipal planning entities.			
Terms:	Priority is given to any county government acting on behalf of its municipalities, any group of two or more municipalities, or a body authorized to act on behalf of two or more municipalities. Eligible uses include preparing and updating of comprehensive community development plans, policies, and implementing mechanisms such as zoning ordinances, subdivision regulations, functional plans such as downtown revitalization, water resource plans, and land development regulations.

Eligibility:	Pennsylvania municipalities and downtowns.				
Terms:	Match required. Eligible uses: Administrative Costs associated with Main Street Manager positions and offices; Physical improvements supported by downtown plan for Downtown Reinvestment Component; Acquisition costs and physical building improvements for Anchor Building component. Funding amounts: Main Street: \$115,000 over a 5-year period; Downtown Reinvestment and Anchor Building components: up to \$250,000 or not to exceed 30% of project cost.

Eligibility:	Pennsylvania local governments.
Terms:	An interdisciplinary team of economic development professionals knowledgeable in all facets of the Stimulus Package that will help communities maximize their use of funding programs.
Deadline:	Varies.

	Program: Tax Increment Financing (TIF) Guarantee Program
Form of Assistance:	Provides a credit enhancement for TIF projects through the use of guarantees to issuers of bonds or other indebtedness. The program's goals include improving market access; lowering project capital costs; promoting and stimulating the general economic welfare of various regions and communities in the Commonwealth; and assisting with the development, redevelopment, and revitalization of brownfield and greenfield sites in accordance with Pennsylvania's TIF Act.
Eligibility:	Municipalities and municipal authorities that issue TIF bonds to fund local economic development.
Terms:	Projects must be located in blighted areas (see the characteristics of blight described in the Urban Redevelopment Law), within a TIF district, and on previously utilized property or on undeveloped property that is planned and zoned for development. Applicants must show that the revenue to be realized as a result of the project will be sufficient to offset the amount of the debt service. They must also demonstrate that the project complies with the TIF Act prior to the issuance of bonds or other indebtedness. Businesses or private developers must agree to create a certain number of permanent full-time jobs within the TIF district. The maximum guarantee amount per project is \$5 million.

Form of Assistance:	Grants to promote and encourage the prosperous development of Pennsylvania business.
Eligibility:	Pennsylvania local governments, counties, redevelopment authorities, and nonprofits.
Terms:	No maximum.
Deadline:	Varies.

Program:	Bikes Belong
Form of Assistance:	Grants for bike facilities, paths, routes, lanes, parks, education, and advocacy.
Eligibility:	Federal, state, regional, county, and municipal agencies, nonprofits, organizations whose mission is expressly related to bike advocacy.
Terms:	\$10,000 or less grants, usually for projects that leverage federal, state, and private funds.
Deadline:	Quarterly.

Program:	Congestion Mitigation and Air Quality (CMAQ) Funding
Form of Assistance:	Flexible funds for qualified transportation projects.
Eligibility:	State and local governments.
Terms:	The SAFETEA-LU CMAQ program provides over \$8.6 billion dollars in funds to State DOTs, MPOs, and transit agencies to invest in projects that reduce criteria air pollutants regulated from transportation-related sources over a period of five years (2005-2009). The formula for distribution of funds considers an area's population by county and the severity of its ozone and carbon monoxide problems within the nonattainment or maintenance area, with greater weight given to areas that are both carbon monoxide and ozone nonattainment/maintenance areas.
Deadline:	Funds are apportioned to the State DOTs on an annual basis. Municipalities should work with counties to program projects that may qualify for CMAQ funds.

Program:	Competitive cost-reimbursement program for projects that contribute to the attainment of the Clean Air Act standards.
Form of Assistance:	Clean Air Act standards.
Eligibility:	Public agencies, incorporated private firms, nonprofits, local and county governments
Terms:	DVRPC's Competitive CMAQ Program funding may be used for up to 80% of costs for transportation-related projects that can help the region reduce emissions from highway sources and meet National Clean Air Act standards. Every project which receives CMAQ funding must produce a reduction of harmful emissions related to transportation and must also be for the public good.
Deadline:	Varies.

Home Town Streets and Safe Routes to School	
Program:	Grants to encourage the reinvestment in and redevelopment of downtowns and establish safe walking routes for children commuting to school.
Form of Assistance:	Federal or state agencies, county or local governments, school districts, nonprofits
Eligibility:	The Home Town Streets program will include a variety of streetscape improvements that are vital to reestablishing our downtown and commercial centers. These projects will include activities undertaken within a defined "downtown" area that collectively enhance that environment and promote positive interactions with people in the area. Projects may include sidewalk improvements, planters, benches, street lighting, pedestrian crossings, transit bus shelters, traffic calming, bicycle amenities, kiosks, signage, and other visual elements. This program will not fund costs related to buildings or their facades or personnel costs related to a Main Street manager. Safe Routes to School is designed to work with both school districts and pedestrian and bicycle safety advocates to make physical improvements that promote safe walking and biking passages to our schools. Collectively, these efforts would save on school busing costs and promote a healthy lifestyle for our children. In addition, some funding may be used for pedestrian education efforts. Examples of these types of improvements include: sidewalks, crosswalks, bike lanes or trails, traffic diversion improvements, curb extensions, traffic circles, and raised median islands.

Program: Infrastructure and Facilities Improvement Program	
Form of Assistance:	Grants provided to certain issuers of debt in order to assist with the payment of debt service.
Eligibility:	Authorities that issue debt for tax increment financing, redevelopment agencies, convention center authorities (includes municipal authorities formed for the purpose of convention center activities), and the Pennsylvania Economic Development Financing Authority.
Terms:	DCED calculates the amount of funding individual projects are eligible to receive based on the amount of state sales tax, hotel occupancy tax, and employer withholding of personal income tax the project is expected to generate. Industrial facilities, such as warehouses and distribution centers are common recipients of these grant funds. Retail properties may also be eligible, provided they will create at least 200 full-time jobs and occupy 200,000 square feet of space.

Form of Assistance:	Grant and low-interest loan financing for public and private infrastructure improvements.				
Eligibility:	Municipalities, industrial development authorities and corporations, municipal authorities, redevelopment authorities and local development districts may apply for IDP assistance for themselves or on behalf of eligible private companies engaged in: agriculture, industrial, manufacturing, research and development, and export services; Real estate developers who are developing sites for eligible private companies.				
Terms:	Loans and grants up to \$1.25 million; No more than 20% of the annual appropriation for a single municipality; Grants for public infrastructure; Loans to private businesses at 3% interest rate; Up to 15-year term; 2:1 private to public match required; \$25,000 cost per job to be created within five years or 10 new full-time equivalent jobs (whichever is greater).

Form of Assistance:	Flexible funds for qualified transportation projects.
Eligibility:	State and local governments.
Terms:	The National Highway System (NHS) is a system of designated corridors of national significance.
