The Commission is an advisory agency which divides its planning and service functions between the Office of the Executive Director, the Office of Public Affairs, and three line Divisions: Transportation Planning, Regional Information Services Center, which includes Regional Planning Office, and Finance and Administration. DVRPC's mission for the 1990s is to emphasize technical assistance and services and to conduct high priority studies for member state and local governments, while determining and meeting the needs of the private sector.



The DVRPC logo is adapted from the official seal of the Commission and is designed as a stylized image of the Delaware Valley. The outer ring symbolizes the region as a whole while the diagonal bar signifies the Delaware River flowing through it. The two adjoining crescents represent the Commonwealth of Pennsylvania and the State of New Jersey. The logo combines these elements to depict the areas served by DVRPC.

ABSTRACT

This report documents the 1990 Census municipal demographic and employment variables used in transportation studies. These data are among the basic inputs to the DVRPC regional travel-demand simulation models, which are used to estimate base-year travel patterns, facility volumes, and emissions generated by mobile sources.

Introduction

The following data tables show the 1990 municipal *population*, *occupied housing units*, *occupied housing units by vehicle availability*, *total vehicle availability*, *employed residents* and *employment*¹. Demographic and employment data are among the basic inputs for DVRPC's regional travel-demand simulation models which estimate base-year travel patterns, travel demand on individual facilities, transit ridership, highway vehicle miles of travel and highway source air pollutant emissions. The data presented here along with the 1970 and 1980 census data constitute the historical base used to forecast year 2000, 2010 and 2020's municipal demographic characteristics and employment, which are documented in Direction 2020 Report 15². These tables cover all municipalities in the Delaware Valley Region (352 municipalities and 12 county planning areas in Philadelphia), as well as three municipalities in Berks County, PA. All demographic variables are counted at the place of residence, and employment is tallied at the place of work. No municipal boundary has been altered during the last decade.

The 1990 census definitions for the variables are as follows³:

Population: the total number of inhabitants in a municipality without regard to race, gender or any other social and economic variables. Population is based on a 100-percent count and the 1990 population is drawn from Table P3 (100-Percent Count of Persons) of STF-3.

Occupied Housing Units: Living quarters are classified as either *housing units* or *group quarters*. A housing unit is defined as a house, an apartment, a mobile home or trailer, a group of rooms or a single room occupied as separate living quarters, or if vacant, intended for occupancy as separate living quarters. If the living quarters contain nine or more persons unrelated to the householder or person in charge (a total of at least 10 unrelated persons), it is classified as group quarters. A housing unit is classified as *occupied* if it is the usual place of residence of the person or group of persons living in it at the time of enumeration, or if the occupants are only temporarily absent; that is, away on vacation or business. Occupied rooms or suites of rooms in hotels, motels, and similar places are classified as housing units only when occupied by permanent residents. In 100-percent tabulations, the count of occupied housing units always equals the count of households or householders. In sample tabulations, the numbers may differ as a result of the weighting process. The number of 1990 occupied housing units is calculated from Table H37 (Tenure by Vehicle Available) of STF-3, which is based on sampling and compatible with the 1970 and 1980 corresponding data used in transportation planning.


Occupied Housing Units by Vehicle Availability: These data are derived from the census long-form questionnaire item H13 (about 17 percent of all households received the long form in 1990). Each category data shows the number of households with the specified number of passenger cars, vans and pickup or panel trucks of one-ton capacity or less, available for the use of household members. Vehicles rented or leased for one month or more, company vehicles, and government vehicles are included, if kept at home for nonbusiness purposes. These data are estimated based on the household sampling distribution and are drawn from Table H37 (Tenure by Vehicle Available) of STF-3 for 1990.

Total Vehicle Availability: These data are calculated from the above occupied housing units by vehicle availability data. Each category is converted into number of vehicles available for that category by multiplying the vehicle availability and the number of occupied housing units, and then summing across all categories to get the total vehicles available for households in a municipality.

Employed Residents: All civilians 16 years old and over who were either "at work" or "with a job, but not at work". "At work" refers to those who did any work at all during the census reference week as paid employees, worked in their own business or profession, worked on their own farm or worked 15 hours or more as unpaid workers on a family farm or in a family business. "With a job, but not at work" refers to those who did not work during the reference week, but had jobs or business from which they were temporarily absent, for whatever reason in the census reference week. Also, persons who served in the United States armed forces are included regardless of whether or not they went to work during the reference week. These data are drawn from Table P70 (Sex by Employment Status) of STF-3 for 1990.

Employment: Unlike demographic variables, employment is tallied by place of work, and as such it measures the number of jobs within a given municipality. The census does not directly provide estimates of employment. The census data for a given municipality consist of counts of work trips going to that municipality from all places during the census reference week. These data underestimate the total jobs in a municipality, because employed persons who did not make a work trip, due to vacation, sickness, or whatever reason, were excluded from the tally. Also, some people had more than one job and made additional work trips during the reference week, but the census only counted work trips to the primary job. To adjust for these errors, the census municipal estimates were factored to the county control totals, based on Bureau of Economic Analysis estimates, Bureau of Labor Statistics ES-202 data, occupational privilege tax data, Dun and Bradstreet data, and other sources.

The 1990 municipal demographic and employment data are listed by county, following a regional map and a county-level summary table. A municipality map (county planning areas map for Philadelphia) precedes county's table. In the tables, the four categories under the header of *Housing by Vehicle Availability* tabulate no-vehicle, one-vehicle, two-vehicle, three- or more-vehicle occupied housing units, respectively. *Total Vehicles* refers to total vehicle availability, or the number of vehicles available for the use of residents. The rest of the variables are defined as above.




