# GOVERNOR MCGREEVEY ADDRESSES TRANSPORTATION FORUM

ver 60 people braved the snow on December 5, 2002 for a meeting of the Central Jersey Transportation Forum. New Jersey Governor *James McGreevey* was in attendance to discuss the implications for the region of his newly introduced Smart Growth initiatives and Executive Order 38.

The meeting was an opportunity for the Governor to update the Forum on New Jersey's designated smart growth areas and their relation to planning areas

of the State Development and Redevelopment Plan. He also described the state's efforts to more closely coordinate smart growth principles as they govern regional growth and impact municipal decisions.

Following his update, Governor McGreevey opened the meeting to the group for suggestions and comments on how to fix the disconnect between regional planning and local zoning in order to achieve smart growth. He also com-

mended the Forum on its progress in addressing regional concerns.

Other issues discussed at the meeting included an update on municipal outreach for the bus rapid transit proposal, and a

presentation of the Delaware River Joint Toll Bridge Commission's Southerly Crossings Corridor Study. The Forum also adopted the Phase 1 Executive Summary of the group's progress thus far.

Created in January of 1999 by DVRPC in the New Jersey Department of Transportation, the Central Jersey Transportation Forum seeks to develop appropriate planning strategies to address critical transportation issues and concerns. The study

area currently covers 17 municipalities in Middlesex, Somerset and Mercer counties. The Forum consists of federal, state and local public officials along with private sector organizations in the region.

## **BICYCLISTS, MOTORISTS IN UNIVERSITY CITY LEARN TO SHARE THE ROAD**

icyclists are a common sight on the sidewalks around University City. Most are not aware that riding on the sidewalk is illegal, and those who are claim that careless motorists make riding on the roads simply too dangerous. In an effort to educate both motorists and bicyclists, DVRPC kicked off its Share the Road campaign in University City on January 17, 2003.

The campaign aims to educate both bicyclists and motorists about their responsibilities to abide by the rules of the road. Over the next several months, University of Pennsylvania (U of P) Police will make "educational stops," handing out Share the Road leaflets to bicyclists riding on the sidewalks, and to motorists encroaching on bicycle lanes. Beginning in the Spring, police will enforce violations by issuing citations to both bicyclists riding on the sidewalks,

and to motorists ignoring bicyclists' rights.

The University City project ROAD will also include other educational efforts in cooperation with the University City District, University of Pennsylvania, Drexel University, the Bicycle Coalition and Neighborhood Bike Works.



The Share the Road campaign began as a joint project of DVRPC, the Pennsylvania Department of Transportation (PennDOT) and the Federal Highway Administration to increase bicyclist safety and comfort on the roads by targeting bicyclists and motorists with messages regarding their respective rights and responsibilities. The Share the Road campaign hopes to change attitudes and behaviors of all road users by increasing bicyclist's competence and confidence in mixed traffic and by improving motorist's awareness and respect for bicyclists.

"It became clear to us that although PennDOT placed Share the Road signs

Transportation Planning. "DVRPC applied to PennDOT for a Transportation Enhancement Fund grant in the year 2000 and then began the process of selecting communities in which to launch the Share the Road program."

University City was one of four areas in the region chosen to participate in a Share the Road campaign. The City of Chester in Delaware County, Ogontz Avenue/West Oak Lane in Philadelphia, and Doylestown, in Bucks County, have also launched initiatives targeted at their own unique bicycling issues. All four Share the Road campaigns are funded by PennDOT and the Federal Highway Administration.

# COVERING OUR ASSETS: DVRPC'S 16TH ANNUAL BOARD RETREAT

he Delaware Valley is brimming with diverse cultural assets, vibrant tourism opportunities, and unique historical institutions. This year's Annual Board Retreat, held on December 5, 2002, at Pen Ryn Manor in Bensalem, gathered over 100 regional leaders to explore opportunities for maximizing these assets to strengthen the region.

The 16th Annual Retreat's theme, Covering our Assets: What puts the "Quality" in our Quality of Life, looked in depth at the region's strengths—our many educational and health institutions, our cultural and ethnic diversity, our vibrant tourism and entertainment industries—all of which combine to make the Delaware Valley a center of growth.

The first session of the retreat featured experts from St. Louis and Detroit, who described how their own organizations have worked to maximize regional amenities in promoting their locales to citizens and industries. In the second session of the day, regional leaders including *Happy Fernandez*, President, Moore College of Arts; *Philip Wallis*, of Natural Lands Trust; *Meryl Levitz*, Greater Philadelphia Tourism and Marketing Corporation; *Richard Bendis*, President,

Innovation Philadelphia; and **Dr. Richard Harris**, Walter Rand Institute, discussed what they see as the region's assets, and suggested ways to build on those strengths to increase the region's competitiveness.

During the luncheon, the **Honorable Robert Borski**, U.S. House of Representatives (PA-3rd District), was honored for his dedicated service to the region during his term in office. Chairman **Charles Martin** presented Mr. Borski with an engraved ice bucket commemorating his retirement from office.

# DVRPC OFFERS ASSISTANCE TO MUNICIPALITIES

uch of the region's progress in achieving long-range goals rests in the hands of 352 individual municipalities and their ability to implement regional planning strategies. In recent months, DVRPC has initiated several programs aimed at helping the region's municipalities move toward this objective.

In the spring of 2002, DVRPC introduced a series of brochures designed to aid municipalities in identifying useful planning tools. In January 2003, DVRPC published the fourth installment in the series, a Guide to Multi-Municipal Planning. The guide focuses on the benefits of collaboration among several municipalities to develop a shared vision. The publication also gives tips on how to begin a multi-municipal effort, offers a case study of successful collaboration, and supplies a list of resources for further information. For municipalities in New Jersey, DVRPC is now offering **Open Space and** Natural Resources Planning Services. The program is designed to assist a municipality in conducting planning for environmental protection, preservation of open space and smart growth. Services offered to a municipality through this program include assistance in identifying the current state of its resources, help with bringing together its leaders and its citizens to articulate a community vision for the future, and development of specific municipal tools to achieve that vision. DVRPC began making presentations to environmental commissions and planning boards in

New Jersey in the Fall of 2002, and was recently contracted for work in Logan Township. Several other townships are expected to follow shortly. The services are subsidized in part by DVRPC's Open Space and Greenways Program, which reduces the expense to municipalities.

Following last April's Building from Strength: Strategies for Older Suburbs and Boroughs conference, a number of municipal representatives expressed an interest in participating in continuing discussions with officials from other first generation communities. In response, DVRPC began a series of "peer-to-peer" municipal forums, which highlight successful case studies; provide municipalities with an opportunity to network with other first generation communities; create a dialogue between government officials as well as non-profit organizations and the private sector; and facilitate inter-municipal cooperation between the region's older suburbs and boroughs. To date, two of these forums have been held in Pennsylvania and one in New Jersey, and at least one additional forum is planned for Spring, 2003. Participants at the initial meetings identified several potential follow-up activities, including advocacy and additional discussions on critical issues facing the region's older suburbs. In addition to these continuing discussions, the Commission has also begun the preparation of two brochures to be distributed to the region's first generation communities, including one describing land value taxation as a potential tool for revitalizing urban centers and a second describing the redevelopment of older vacant or under-utilized shopping centers, also known as "greyfields".



# DVRPC FUNDS NEW PROJECTS IN FY 2004

VRPC's FY 2004 Planning Work Program was officially adopted by the Board at its January 23, 2003 meeting. This year's work program addresses issues currently facing the region, while furthering long-range plans for orderly growth. The document outlines all of the federally funded planning projects slated for the nine-county region from July 1, 2003 to June 30, 2004. The listing includes DVRPC projects, as well as projects planned by member governments and transit organizations.

New projects for FY 2004 include a Regional Car Sharing Program; a study of recent land development trends in the Philadelphia suburbs; a feasibility study to ease access to the Mercer County Airport; and a Gloucester County Bike and Pedestrian Trails Network. A total of 19 new projects were chosen from recommendations of DVRPC's committees and county governments.

Development of the Work Program began in the Fall of 2002, and a full draft was released for review at the Board Retreat on December 4, 2002. After its adoption by the Board in January, the document was sent to both NJ DOT and PENNDOT for final approval in March, 2003. Meant to serve as a flexible document, the Work Program can be, and often is, amended to respond to the changing needs of our region.

educating citizens of the Delaware Valley about this pollutant. It was also a chance for the Partnership to build ties with regional media and to get feedback to make the forecasts more helpful for reporters.

The Ozone Action season officially begins with a Kick-off in mid-May, and continues into September. \*\*
