1. About the Program

- Congestion Mitigation and Air Quality (CMAQ) is one of many types of **federal** funds created by transportation legislation: ISTEA in 1991 and reauthorized in 2015 by the FAST Act.
- CMAQ provides for capital transportation projects that will reduce emissions from surface transportation modes (e.g. cars) and congestion to improve air quality and/or reduce congestion.
- Projects awarded from this program must adhere to state and federal requirements.
- This is not a grant. Sponsor (public agency) pays first and is then reimbursed for costs incurred after federal authorization of CMAQ funds.



2. Funding

- DVRPC has set aside **\$5 million CMAQ** funds in the Transportation Improvement Program (TIP) over FY2022, 2023, and 2024.
 - Of the total amount, \$1 million CMAQ is dedicated to provide for construction-ready Circuit Trails.
- The federal Fiscal Year (FY) begins Oct. 1 until Sept. 30.
- Awarded projects must be <u>authorized</u> (not actually started or completed) between October 1, 2021 and August 31, 2024. Transit vehicle acquisitions would occur during this period via NJ TRANSIT's procurement process.
- "<u>Authorization</u>" or "<u>Obligation</u>" is the federal government's "<u>commitment</u>" to the federal share of the project cost. This happens first before a project physically begins.



2. Funding (Continued)

- No maximum project cost limit.
- Minimum cost request: \$250,000 for a construction project only
- Local match not required, but may make project more favorable.



3. Schedule

- May 22, 2020 or earlier: Meet with DVRPC about your project
- May 29, 2020: Applications due online (direct link is https://www.dvrpc.org/asp/cmaqApplication/login.aspx)
 - Application Form
 - Cost Estimate Table
 - Vehicle Inventory (only for transit projects)
 - Emission Analysis Form
- June 30, 2020: Commitment/support letters (required), resolutions, Buy America certification (if needed), and/or agreements due
- June September 2020: Project screening, evaluation, air quality analysis, and selection
- October/November 2020: Awards and regrets notification



4. Who is Eligible to Apply

- Any local unit of government
- Transit operators
- State agencies
- Private firms and non-profits <u>must</u> partner with a local public agency sponsor (LPA)

<u>Project Sponsor</u> must be a <u>Public Agency</u>, even if it is a Private-Public Partnership (P3).



5. Eligible Project Types (Air Quality Benefit)

- Alternative Fuel Infrastructure
- Bicycle and Pedestrian Facilities and Programs
- Congestion Reduction and Traffic Flow Improvements
- Experimental Pilot Projects
- Extreme Low-Temperature Cold Start Programs
- Freight/Intermodal
- Idle Reduction
- Inspection & Maintenance Programs
- Public Education, Outreach, and Training Activities



5. Eligible Project Types (Air Quality Benefit) (Continued)

- Transportation Control Measures
- Transportation Demand Management (TDM)
- Local Mobility Initiatives for the general public and comply with ADA
 - Transit Vehicle Purchase(s) to <u>Expand</u> an Existing Service
 - Transit Vehicle Purchase(s) to <u>Introduce</u> a <u>New</u> Service

Tip: You can use the DVRPC Transit Network Gap Analyzer at <u>https://www.dvrpc.org/Webmaps/RTSP/#gap/tool</u> to demonstrate the need for the proposed service.

 Transit Operating Assistance ("Seed \$" for up to the first 3 years)
 All local mobility initiatives applicants must not duplicate existing services and must contact NJ TRANSIT Community Transportation Manager Anna Magri at <u>AMagri@njtransit.com</u> before applying.



6. Ineligible Project Examples (No Air Quality Benefit)

- Maintenance/State of Good Repair/reconstruction/rehab projects
- Construction of Single-Occupancy Vehicle (SOV) capacity projects
- Operating costs for bikeshare programs
- Traffic signal replacements/upgrades without interconnecting/optimizing
- Moving roadways or intersections
- Stand-along projects to purchase fuel or vehicle fuel conversions
- Compliance with a government requirement
- Litigation costs
- Scrappage programs
- Streetscaping



6. Ineligible Project Examples (No Air Quality Benefit)

- Transit vehicle purchase(s) for a service not open to the general public
- Pre-construction or pre-acquisition activities
- Transit facilities and transit-associated development activities

Due to Buy America processing delays:

- Diesel retrofit projects, *unless* a Buy America certification is submitted to DVRPC by June 30, 2020
- Advance technology vehicles, *unless* a Buy America certification is submitted to DVRPC by June 30, 2020



7. Minimum Project Requirements

- Result in reduced emissions and/or ease traffic congestion.
- Consistent with <u>DVRPC Long-Range Plan</u> and/or county master plan goals
- Transit projects must support DVRPC Equity Through Access Plan (<u>www.dvrpc.org/ETA</u>) and demonstrate need and the potential for/demonstrated success
- Location within a DVRPC Congested Subcorridor (www.dvrpc.org/congestionmanagement)
- Federal authorization between Oct. 1, 2021 and August 31, 2024.
- Project sponsor must be a public agency, even if it is P3.



7. Minimum Project Requirements (Continued)

- Project sponsor must keep DVRPC, county/city, and appropriate state agency (e.g. NJDOT, NJ TRANSIT) informed of project's progress towards advancement in a timely and reasonable manner.
- Comply with Buy America (if needed, applicant must submit a Buy America certification by June 30, 2020).
- A traditional construction project must request at least \$250,000 CMAQ funds, which includes cost of construction inspection and management.




8. Project Sponsor Requirements

- Project Sponsor (Public Agency) must receive NJDOT Federal-Aid certification for a construction project.
- Project Sponsor will not be reimbursed for work/costs incurred before funding is federally authorized.
- Do <u>not</u> initiate activities for the federal CMAQ share of the project until:
 - Project is approved by the DVRPC Board for inclusion in the DVRPC NJ TIP;
 - Project Sponsor receives award letter from DVRPC; and
 - CMAQ award is authorized with a notice to proceed.
- After funds are authorized, Project Sponsor is responsible to implement and complete the project in a reasonable manner.



9. Project Selection Criteria

See Appendix A of Program Guidance for full details!



Project Readiness (for Federal Authorization in FY2022, 2023, or 2024)

Sponsor Capacity

25 points max each

20 points

max each

Project Readiness (25 out of 100)

- Will your project be <u>authorized</u> within the time period of Oct. 1, 2021 and August 31, 2024?
- Will your project be implemented in a timely manner <u>after</u> receiving federal authorization?
- For construction projects, has the environmental work (e.g. CED) be completed or in progress of completion? See annual deadlines for document submission in Table 3 of Program Guidance (page 20).
- Is your schedule realistic?

Rating:

- **25 Points:** High Degree of Confidence
- 12.5 Points: Somewhat Confident
- No Points: Slightly Confident or Not at All



Sponsor Capacity (25 out of 100)

- Project Sponsor's ability and commitment to deliver the project, its institutional capacity to manage project, and history of implementing federal-aid projects
- The applicant should convey the Project Sponsor's capacity by describing their experience successfully managing grants for similar projects, clearly defining the roles and responsibilities of each of the project partners, and demonstrating that matching funds and other sources of project funds (if any) are/will be secured in the application.
- Rating:
 - 25 Points: High/Very Successful in authorization & implementation of federal-aid projects
 - 12.5 Points: Sponsor has experience and has *adequate* capacity. No poor experience.
 - No Points: No confidence in Sponsor's capacity & commitment.

Cost Effectiveness of Emissions Reduction (20 out of 100)

- CMAQ Portion of the Project Total Cost divided by sum of project's lifetime NO_x, VOC, and PM_{2.5} emissions reductions
- Submit Emission Analysis Forms:
 - 1. Transit vehicle replacement
 - 2. Roundabout
 - 3. Bicycle and/or Pedestrian Improvements

- 4. Carpool and Vanpool Improvements
- 5. Signal Synchronization
- 6. Intersections
- Applicants with project types that cannot be analyzed, or do not have Emissions Analysis Forms appropriate to their projects, must provide sufficient information about the projects in their application forms.
- Breakdown of points in Appendix A of Program Guidance.

Long-Term Viability of Emissions Benefit (20 out of 100)

- Can your project's air quality/emissions reduction benefits be sustained over time?
- Rating:
 - 20 Points: Over 10 years
 - 10 Points: Between 5 and 10 years
 - 5 Points: Less than 5 years or can't definitely demonstrate benefits beyond 5 years
- See Table 4 in Program Guidance for examples.
- Applicants should explain, as specifically as possible, the long-term outlook and lifespan of the air quality benefits of the project.

Environmental Justice, EJ (5 out of 100)

- What is the EJ score of a census tract that a project location may impact?
- How will the project benefit the EJ population groups: low-income, racial minority, and ethnic minority?
- Applicants should use the DVRPC Equity Analysis tool at <u>www.dvrpc.org/webmaps/IPD</u> to answer questions in the application form.
- Applicants should identify community groups or stakeholders in the project's geographic area that the Project Sponsor would partner with and mitigation and outreach strategies that will be included in the project scope of work. This qualitative section will be awarded up to 1 point.
- See Table 5 and Appendix A in the Program Guidance.

Level of Match (5 out of 100)

- A larger local contribution will result in a higher score for this criterion.
- Provide the match amount in application form and "Cost Breakdown" table.
- The applicant should describe all preliminary work performed to prepare the project for implementation and quantify cash contributions and in-kind services dedicated to the project.
- Rating:
 - **5 Points**: More than 30% contribution to total project cost
 - 4 Points: More than 20% but less than 30%
 - **2.5 Points**: More than 10% but less than 20%
 - **1 Point**: More than 5% but less than 10%
 - 0.5 Points: Less than 5%
 - No Points: No % contribution



10. Application Submission

- 1. New and past applicants must create an online account at <u>https://www.dvrpc.org/asp/cmaqApplication/login.aspx</u>
- 2. Pass a quiz, then create a new project record in system.
- 3. Download, complete, and upload the project application form and other forms in the online system.
- 4. Email <u>khui@dvrpc.org</u> or call 215-238-2894 to schedule a meeting about your project before May 22, 2020.
- 5. Upload your application materials and "submit" by 5:00 p.m. on May 29, 2020.
- 6. Upload and submit letter(s)of intent/commitment/support, Buy America certification if needed), agreement(s), or governing resolutions, policies, etc. by 5:00 p.m. on June 30, 2020.



In the selection criteria, a project's air quality impact (Cost Effectiveness of Emissions Reduction and Long-Term Viability of Emissions Benefit) has the highest weight at 40 out of a maximum 100 points, followed by Project Readiness and Sponsor Capacity.
