3. Contract Authorization: FY 2025 Camden County Local Concept Development Intersection Study for Williamstown Road (CR536 Spur) and Erial Road (CR 706) Intersection Improvements

The Delaware Valley Regional Planning Commission ("DVRPC") issued a **Request for Proposals (the "RFP")** seeking consultant support for the preparation of a Local Concept Development (LCD) study being advanced through its Local Capital Project Delivery (LCPD) Program. This program is consistent with the Project Delivery Process (PDP) recently implemented by the New Jersey Department of Transportation (NJDOT). Through this RFP, DVRPC is seeking to engage one (1) firm to provide professional consultant services in Camden County to conduct an LCD study of Williamstown Road (CR536 Spur) and Erial Road (CR 706) Intersection Improvements, in Winslow Township, New Jersey.

The RFP was released on November 26, 2024, and was posted on OpenGov. Proposals were due on January 10, 2025. In response, DVRPC received nine (9) proposals.

As part of a qualifications-based procurement process, an RFP evaluation committee was created consisting of representatives from DVRPC. Each proposal submitted was evaluated in adherence to the following weighted criteria:

- Technical approach and product understanding (40 points)
- Professional qualifications and experience in similar work (30 points)
- Ability to perform within schedule (30 points)

Based upon the evaluation and scoring of proposals, the Evaluation Committee identified **Dewberry Engineers Inc.** as the top-ranked firm and is the recommended awardee.

DVRPC staff will work with Camden County partners and **Dewberry Engineers Inc.** to ensure timely and successful implementation and completion of the project deliverables.

The contract will be for a not-to-exceed amount of \$370,000.

Action Proposed:

The DVRPC Executive Committee authorizes the Executive Director to enter into and execute a contract with Dewberry Engineers Inc., with a not-to-exceed amount of \$370,000, for an initial term of eighteen (18) months.

Pursuant to satisfactory performance of the Services, Dewberry Engineers Inc. may be retained for additional work on the project, with costs to be determined at that time. Should additional funding become available for related work, DVRPC may negotiate with Dewberry Engineers Inc. to perform related work for up to four (4) additional years.
