### 1. Public Comment on Any Agenda and Non-Agenda Items

## 2. Highlights of the March 7, 2022 RTC Meeting

The highlights from the March 7, 2023 meeting of the RTC were presented for adoption.

Motion: by Jim Mosca seconded by Tonyelle Cook-Artis that the RTC adopt the highlights of the March 7, 2023 RTC meeting.

Motion passed. All votes were cast in favor of the motion.

#### **BOARD AGENDA ITEMS**

## 2a. NJ22-116 Route 295/42/I-76, Direct Connection, Contract 4 (DB #355E), Camden County

The RTC recommends:

Board approval of TIP Action NJ22-116, NJDOT's request that DVRPC amend the FY2022 TIP for New Jersey by delaying the Construction (CON) phase of the Route 295/42/I-76, Direct Connection, Contract 4 (DB #355E) project from FY24 to FY25 and increasing the CON cost estimate by \$28.058 M. The multi-year NHFP-HWY funding and NHPP funding for the CON phase will be reprogrammed as follows:

- FY25: \$156.147 M (\$80.721 M NHFP-HWY/\$75.426 M NHPP)
- FY26: \$139.442 M (\$50.677 M NHFP-HWY/\$88.765 M NHPP)
- FY27: \$52.911 M NHPP

The CON Phase will have an overall increase of \$28.058 M, from \$320.442 M (131.398 M NHFP-HWY/\$189.044 M NHPP) to \$348.5 M (131.398 M NHFP-HWY/\$217.102 M NHPP).

Motion: by *Matthew Lawson seconded by Nick Cressman*, that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

## 2b. PA23-35 Fleecy Dale Road Reconstruction (MPMS #118425), Bucks County

#### The RTC recommends:

That the Board approve TIP Action PA23-35, PennDOT's request that DVRPC amend the FY2023 TIP for Pennsylvania by adding a new project into the TIP, Fleecy Dale Road Reconstruction, in the amount of \$3,115,000 State 581 by programming the project as follows: \$500,000 for Preliminary Engineering (FY23: \$250,000, FY24: \$250,000); \$25,000 for the Utility Phase in FY25; \$90,000 for the Right of Way Phase in FY25, and \$2,500,000 for Construction (FY27: \$122,000, FY28: \$250,000, FY29: \$250,000, FY30: \$250,000, FY31:\$407,000, FY32: \$407,000, FY33: \$407,000, FY34: \$407,000).

Motion: by *Rich Brahler, seconded by Matt Edmond,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

## 2c. PA23-36 Statewide Multimodal Transportation Fund Projects (Various MPMS #s), Various Counties

#### The RTC recommends:

That the Board approve TIP Action PA23-36, PennDOT's request that DVRPC accept the listed Statewide MTF projects, as well as their additional funds into the FY2023 TIP for Pennsylvania. Five projects with the total amount of \$7,654,000 (\$5,245,000 State 411/\$2,409,000 LOC) will be added to the TIP:

#### **Bucks County**

 Business Commons Sidewalk Connections (MPMS #118390) – \$1,135,000 (\$873,000 State 411/\$262,000)

### Montgomery County

- East Norriton Bridge Repairs Improvements (MPMS #118393) \$121,000 (\$93,000 State 411/\$28,000 LOC)
- Brownlie Road Culvert Replacement (MPMS #118394) \$1,018,000 (\$780,000 State 411/\$238,000 LOC)
- West Monument Avenue Bridge (MPMS #118395) \$881,000 (\$499,000 State 411/\$382,000 LOC)

### City of Philadelphia

5th Street: Luzerne - Mentor (MPMS #118391) – \$4,499,000 (\$3,000,000 State 411/\$1,499,000 LOC)

Motion: by *Jim Mosca, seconded by Matt Edmond,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

#### 2d. PA23-37 Downingtown Train Station Rehabilitation (MPMS #93586), PennDOT

#### The RTC recommends:

That the Board approve TIP Action PA23-37, PennDOT's request that DVRPC amend the FY2023 TIP for Pennsylvania by reducing funding in the TIP for the Construction Phase of the Downingtown Train Station Rehabilitation project by \$14,492,000 (\$11,593,000 5337/\$2,899,000 State 341).

Motion: by *Brian Styche, seconded by Kellie Bellina,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

### 2e. PA23-38 SEPTA Bus Purchase Program (MPMS #90512), SEPTA

#### The RTC recommends:

That the Board approve TIP Action PA23-38, SEPTA's request that DVRPC amend the FY2023 TIP for Pennsylvania by increasing the FY23 PUR Phase of the SEPTA Bus Purchase Program (MPMS #90512) by \$22,452,000 (\$15,023,000 Section

5307/\$2,010,000 Section 5339/\$5,270,000 State 1514/\$149,000 LOC) to support the procurement of 120 New Flyer 40-foot Hybrid Buses.

Motion: by *Tonyelle Cook-Artis, seconded by Kellie Bellina,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

### 2f. PA23-39 Vehicle Overhaul Program (MPMS #60582), SEPTA

The RTC recommends:

That the Board approve TIP Action PA23-39, SEPTA's request that DVRPC amend the FY2023 TIP for Pennsylvania by decreasing the FY23 Capital Asset Construction (CAP) Phase of the Vehicle Overhaul Program (MPMS #60582) by \$17,007,000 (\$9,738,000 Section 5337/\$3,868,000 Section 5307/\$3,291,000 State 1514/\$110,000 LOC) to meet program needs.

Motion: by *Kellie Bellina, seconded by Tonyelle Cook-Artis,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

## 2g. PA23-40 Substations and Power Improvements (MPMS #60651), SEPTA

The RTC recommends:

That the Board approve TIP Action PA23-40, SEPTA's request that DVRPC amend the FY2023 TIP for Pennsylvania by increasing the FY23 Engineering/Right of Way/Construction (ERC) Phase of the Substations and Power Improvements program (MPMS #60651), by \$21,376,000 (\$17,944,000 Section 5337/\$3,277,000 State 1514/\$155,000 LOC) to meet program needs.

Motion: by *Tom Shaffer, seconded by David Kanthor,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

#### 2h. PA23-41 I-95, PA Turnpike Interchange Stage 2 (MPMS #119730), Bucks County

The RTC recommends:

That the Board approve TIP Action PA23-41, PTC's request that DVRPC amend the FY2023 TIP for Pennsylvania by adding a new I-95, PA Turnpike Interchange Stage 2 project into the TIP, in the amount of \$153,000,000 Turnpike (TPK) funding, programmed as follows: \$8,600,000 TPK for Final Design (FY23: \$1,500,000, FY24: \$3,100,000, FY25: \$2,000,000, FY26: \$2,000,000); \$2,500,000 for Right of Way (ROW) (FY23: \$1,000,000, FY24: \$1,500,000); and \$142,000,000 for Construction (CON) (FY23: \$10,000,000, FY24: \$37,000,000, FY25: \$59,000,000, FY26: \$36,000,000).

Motion: by *Rich Brahler, seconded by Jim Mosca,* that the RTC recommend the Board approve the TIP action.

Motion passed. All votes were cast in favor of the motion.

## 3. Federal Functional Classification and Intermodal Connector Changes, Bucks County

The RTC recommends:

Board approval of these Federal Functional Classification and Intermodal Connector changes:

- 1. SR 2073 South Pennsylvania Avenue. Segments 0020-0060 (Tyburn Road to US 1) from Minor Arterial (FC 4) to Major Collector (FC 5) and removal of Intermodal Connector designation.
- 2. SR 2055 Philadelphia Avenue. Segments 0078-0110 (Tyburn Road to South Pennsylvania Avenue) from Minor Arterial (FC 4) to Major Collector (FC 5)
- 3. SR 2020 Tyburn Road. Segments 0030-0081 (US 13 to South Pennsylvania Avenue) from Minor Arterial (FC 4) to Principal Arterial (FC 3) and addition of Intermodal Connector designation.

Motion: by *Rich Brahler, seconded by Matt Lawson,* that the RTC recommend the changes:

Motion passed. All votes were cast in favor of the motion.

# 4. DVRPC FY 2023 Work Program Amendment: Regional Vision Zero 2050 Action Program

The RTC recommends:

That the Board amend the FY 2023 Work Program to include RVZ – the Regional Vision Zero 2050 Action Program.

Motion: by *Tom Stanuikynas, seconded by Kelley Yemen,* that the RTC recommend the Board amend the FY 2023 Work Program to include RVZ – the Regional Vision Zero 2050 Action Program.

Motion passed. All votes were cast in favor of the motion.
