[who we are and what we do]

Our goal is to address current and ongoing issues while fostering cooperation among member governments, private sector organizations, and the general public. To do so, we work closely with a variety of groups, including the Pennsylvania and New Jersey departments of transportation, community affairs and environmental protection agencies, the federal government, and regional transportation providers. We also partner with a wide variety of non-profit organizations in the areas of community and economic development, environmental protection, and land use.

All of our activities are directed by an 18-member Board which establishes regional policy, defines committee duties, and adopts the annual work program. A 10-member Executive Committee oversees general operations and fiscal matters. Financial support for our activities comes primarily from federal transportation funding through the Pennsylvania and New Jersey departments of transportation. Additional financial resources are provided by funding from other state or federal agencies, counties, cities, operating agencies, foundations, and the private sector.

For example, DVRPC welcomed over 300 elected officials and planning professionals from across the country, when we served as the local host for the National Association of Regional Councils (NARC) Conference. In addition, at our Board Retreat last December, we honored individuals and programs that share our mission of making a great region even greater. These are just a few examples of what we do. OUR ROADMAP TO A MORE SUSTAINABLE FUTURE

ast year, representatives of the Governors of Pennsylvania and New Jersey, together with officials from the four cities and eight counties that comprise our Board, endorsed *Connections 2040*, DVRPC's plan for future growth and development in the Greater Philadelphia region.

The Plan's vision calls for a more sustainable future that offers a superior quality-of-life by increasing mobility choices, preserving more open space, reinvigorating our existing communities, and building our economy by reducing demand for energy. The Plan envisions more compact, mixed-use development, shortening distances between destinations and encouraging alternative forms of transportation. Less energy

use will help to reduce carbon dioxide (CO₂) emissions, making the region more sustainable and economically competitive. By spending less on building new infrastructure farther out from the urban core, more investments can be made in improving our existing infrastructure.

Connections 2040 is guided by four core principles:

- Manage growth and protect the environment
- Create livable communities
- Build the economy
- Establish a modern multimodal transportation system

Last year, as a component of the long-range plan update, DVRPC

examined how different future funding levels will affect transportation infrastructure conditions in a report, Connections 2040: Transportation Investment Scenarios. To help stakeholders and residents better understand and visualize what the different scenarios mean for our region, DVRPC launched an interactive web application called *Connections 2040*: Choices & Voices. The website allows users to develop their own vision for the region by identifying their preferred building pattern and deciding how to invest in our transportation system. All DVRPC initiatives support at least one of the plan's core principles listed above. This report summarizes work completed by DVRPC in the last year.

[a modern transportation system]

functional transportation network is vital to the region's quality-of-life and economic competitiveness; as future population and employment increase, we must ensure that our system can meet these growing demands. Our challenge is how to maintain our aging infrastructure as well as a growing backlog of transportation projects that are essential to our region's progress.

Over the past few years, DVRPC and our state planning partners at PennDOT and NJDOT, along with regional transit providers at SEPTA, PATCO, and NJ Transit, have been working together to better understand and prioritize projects that will have maximum impact on our region's mobility while making the most effective use of limited dollars.

In order for our region to receive federal transportation funds, DVRPC develops a Transportation Improvement Program (TIP). This prioritized list of projects includes highway, transit, bicycle, pedestrian, and freight-related projects. Last year, DVRPC approved \$1.7 billion in funding for the FY2014–17 New Jersey TIP. The new Pennsylvania TIP will be developed in 2014.

All projects listed in the TIP must be drawn from the recently approved *Connections* 2040 Long-Range Plan, and help implement the goals of the plan, such as those that will establish a modern transportation system or make investments in areas that have been identified for development.

[improved corridors]

s our region continues to grow, it is important to ensure that the transportation system can handle changes in travel patterns. Each year, DVRPC looks at specific corridors in the region to identify challenges and make recommendations that guide future transportation and land use decisions.

Selected locations are chosen based on the Congestion Management Process (CMP) and long-range plan. This year, DVRPC made recommendations for access management policy and safety on Ridge Pike in Lower Providence Township, Montgomery County; and identified safety and mobility improvements for US 30 in Radnor Township, Delaware County. Staff also prepared an interactive, web-based

Asset Management Tool for eight
Pottstown-area communities; the tool
uses GIS to track structural conditions
on local roads and bridges. Working
with Camden County, the Commission
also helped update the county's Highway
Master Plan by assessing traffic safety
and performing travel demand modeling.

An important component of transportation planning is the ability to forecast future travel using a well-tested travel modeling process. As part of DVRPC's long-range planning efforts, it was vital to have a firm understanding of the region's current travel characteristics in order to produce

reasonable forecasts of future highway and transit travel for our studies. Last year, DVRPC completed work on the Travel Improvement Model (TIM) 2.0 — a new package of computer programs that simulate regional travel behavior. To learn more about modeling, see WWW.DVRPC.ORG/TRANSPORTATION/MODELING.

Last year, DVRPC also began work on a region-wide household travel survey. Done every ten years, the study collected data about daily travel behavior, which will inform future transportation projects. To learn more, visit WWW.DVRPC.ORG/TRAVELSURVEY.

[safe roads]

VRPC strives to make our region's roads safer for all users. Transportation safety is incorporated into many of the Commission's activities, ranging from technology to operations to incident management. The goal is to preserve capacity and improve security, safety, and reliability of our transportation systems.

Each year, the Commission issues a *Crash Data Bulletin* which collects information about crashes, such as what causes them, and the number of injuries and fatalities. Data is broken down by county and compared with the previous year. The most recent bulletin showed that in 2011, fatalities increased by 10% but there was a slight decrease in total crashes and people injured.

Guided by the *Transportation Safety*Action Plan, DVRPC examines high-crash


areas in the region and recommends ways to make them safer through Congestion and Crash Site Analyses and Road Safety Audits. These studies not only look at reducing vehicle crashes, but make it safer to bike, walk, and take transit. For more details and to view recent audits, visit WWW.DVRPC.ORG/SAFETY.

A growing role for DVRPC has been to assist the region's transportation providers in better managing and operating their systems. This includes supporting an integrated program to optimize the performance of the existing infrastructure through implementation of multimodal cross-jurisdictional systems, services, and projects.

DVRPC manages a forum for emergency responders to meet and coordinate efforts. The Traffic Incident Management Program

includes Incident Management Task Forces (IMTFs) and provides software applications (RIMIS and IDRuM) to improve incident response. In fact, RIMIS was used this year at the U.S. Open and the Independence Day festivities to help manage traffic. Also last year, DVRPC coordinated with FHWA to bring the National Traffic Incident Management "Train the Trainer" course to the region. In addition, two new IMTFs were created in Burlington and Bucks counties.

Other activities included work on the US 30 ITS Master Plan; the PA Regional Traffic Signal Retiming Project; a mapping project that designated detour routes for flood prone areas on the Lower Wissahickon Creek Watershed; and a program that monitored ITS efforts for the I-295 Direct Connect project. IMPROVING SAFETY ON PA 100

CRASHES ALONG PA 100 IN NORTHERN CHESTER COUNTY WERE REDUCED BY 30% BETWEEN 2007 AND 2011 THANKS TO A \$1.5 MILLION INVESTMENT IN SAFETY-RELATED IMPROVEMENTS. FOLLOWING SEVERAL FATAL CRASHES BETWEEN 2003 AND 2006, DVRPC EXAMINED AN EIGHT-MILE SEGMENT OF PA 100 AND RECOMMENDED A LIST OF SHORT-TERM, IMMEDIATE SAFETY MEASURES. THE IMPROVEMENTS INCLUDED A ROADWAY SURFACE FRICTION TREATMENT (NOVA CHIP) FOR REDUCING HIT-FIXED-OBJECT CRASHES, TREE MANAGEMENT TO HELP THE ROADS DRY FASTER, SIGNAGE, AND SPEED ENFORCEMENT.

[multimodal transportation system]

ccessibility to mass transit and alternate means of transportation for everyone in the region is a top priority at DVRPC; we plan with this long-range goal in mind.

As such, DVRPC has been working with Chester County to develop a public transportation plan. As part of this effort, planners explored current travel patterns, transit usage, and service gaps in the county. Two public/stakeholder workshops were held to assist in project prioritization.

The Commission also explores opportunities to improve access to transit stations, as well as safety for bicyclists and pedestrians. The RideScore project assists municipalities and transit agencies in strengthening regional connections between trails and transit stations. Once complete, a database will be searchable by station and by characteristic to assess the existing, and potential future, relationship between transit and trails.

On the Norristown High Speed Line, DVRPC identified opportunities to increase parking capacity, while simultaneously improving access to stations on foot or by bicycle. At the Norristown Transportation Center, staff evaluated usage, needs, and opportunities to develop a master plan. To improve access for bicycles and pedestrians along South Broad Street in Philadelphia, the Commission completed a concept plan for a sidepath. In New Jersey, DVRPC outlined strategies to facilitate better access to the Pennsauken Transit Center and also identified economic development opportunities within the station area.

Working with SEPTA and other planning partners, DVRPC developed SEPTA's first set of design guidelines for bus stops, stop areas, and the incorporation of bus stop facilities into the development review process. The guidelines will provide municipalities, developers, and local partners with a consistent framework for designing surface transit stops.

DVRPC has also identified completion of The Circuit, Greater Philadelphia's regional trail network, as a priority in Connections 2040. To further this goal, the Commission administers the Regional Trails Program, which has provided over \$9 million to date to plan, design, and build multi-use trails in the region. DVRPC also provides planning guidance and technical assistance in support of trail development and has launched a program to develop ongoing, automated counts of trail users for use in trail planning and improvement projects. Also last year, DVRPC created a walking tour dedicated to exploring what African American life would have been like in the late 1800s in Society Hill, or the "Seventh Ward." The tour was developed through a process of research and analysis with the goal of highlighting African American historic sites in Philadelphia.

BOOSTING THE LAWRENCE HOPEWELL TRAIL

AS PART OF THE REGIONAL TRAILS PROGRAM, DVRPC AWARDED \$250,000 TO THE LAWRENCE HOPEWELL TRAIL CORPORATION TO ADD 1.8 MILES TO THE LAWRENCE HOPEWELL TRAIL. THIS TRAIL IS PART OF THE CIRCUIT, GREATER PHILADELPHIA'S REGIONAL TRAIL NETWORK. VRPC strives to ensure that all people, despite their income or ability, have access to transportation choices. The Coordinated Human Services. Transportation Plan (CHSTP) identifies transportation needs of older adults, people with low incomes, and individuals with disabilities. In FY13, DVRPC assisted in the grant selection for the Job Access and Reverse Commute (JARC) program and New Freedom program in southeastern Pennsylvania and southern New Jersey. These programs help fund transportation services and supportive activities that facilitate access to jobs for welfare recipients, lower income persons, and reverse commuters.

To accommodate the needs of commuters who are faced with rising fuel and transportation costs and encourage the use of public transportation, DVRPC administers and promotes RideECO. This commuter benefit program was rebranded and launched last year; the ECO stands for Easy Commute Options. RideECO provides a tax break to both employers and their employees who use transit and can help commuters save over \$900 annually by purchasing transit fares using pre-tax dollars. Through its Mobility Alternatives Program, DVRPC helps companies improve their benefits package and even help employees save time and money on their commute. For those who must drive to work. ur freight and aviation systems are crucial to the long-term viability of the region and provide significant economic benefits.

DVRPC has conducted the Aircraft Operations Counting Program for all non-towered regional airports since 1986. Funded by the Federal Aviation Administration (FAA), this program provides seasonal and annual take-off and landing totals as well as based aircraft counts. Last year, the Commission completed counts at 16 airports. In addition, work began on the 2040 Regional Airport Systems Plan, which will be completed in spring 2014.

mart growth encourages the revitalization of urban areas, mixed-use development, and land conservation, while discouraging sprawl. During FY13, DVRPC launched a new web tool that shows smart growth initiatives in the Delaware Valley region, including developments near transit, traditional neighborhood developments (TND), and conservation subdivisions, which build new homes on only a portion of the site to preserve open space and protect sensitive land. These initiatives were chosen for the initial launch of the website because of their potential to revitalize existing urban centers and older communities. To view the tool. visit WWW.DVRPC.ORG/WEBMAPS/SGPD. In addition to promoting future development, DVRPC serves as a resource for established towns, businesses, and planning professionals. Last year, the Commission published a Municipal Implementation Tool titled "Implementing Shared Services" and hosted a forum of the same name. Both formats explored best practices and addressed legal issues in the joint administration of municipal services for multiple governmental agencies. Additional municipal support was given through research and publications on best practices in land preservation through noncontiguous parcel clustering and zoning for wireless service facilities. To identify ways to improve these outreach efforts. DVRPC conducted its Municipal Outreach Survey.

The Regional and Community Economic Development Forum (RCEDF) hosted a panel discussion exploring the benefits of, and obstacles to, establishing a thriving creative business in the Greater Philadelphia region. The RCEDF provides a place for people with diverse perspectives to learn from each other and contribute to regionwide discussions on timely topics. any of the region's mature communities face social, economic, and infrastructure challenges uncharacteristic of more affluent exurban communities; many also lack the resources available to the region's core cities. The Strategies for Older Suburbs (SOS) program develops techniques and strategies, and works with member governments to facilitate revitalization and networking.

Through the SOS program, staff compiled information about 71 suburban downtown retail districts in an effort to learn what elements were common among successful older suburban retail districts. Short-and long-term goals were developed to help local officials revive these districts and further their economic development goals.

Revitalizing Downtown Retail Districts strives to improve the quality of life in our older suburbs.

DVRPC developed its Classic Towns of Greater Philadelphia marketing program (WWW.CLASSICTOWNS.ORG) to celebrate older neighborhoods and communities on both sides of the river as vibrant places to live, work, and play. During FY13, DVRPC held the first ever "I Love Classic Towns" photo contest. Professional and amateur photographers from throughout the region submitted over 1200 of their favorite photos of the main streets and environs of Pennsylvania and New Jersey's Classic Towns. A jury reviewed and selected the winning photos, and a subsequent gallery exhibition toured ten Classic

Towns throughout the fiscal year, with each town hosting the show for approximately one month.

In addition to the Classic Towns initiative, DVRPC hosted Strategies for Older Suburbs roundtable events as part of a program that encourages networking in developed communities. The topics discussed included Maximizing the Potential of a Downtown Retail District, Diversify Your Resources, and Engaging Local Business Owners. VRPC's environmental planning programs encompass open space and greenway planning, regional trail network development, the Pennsylvania Coastal Zone Management Program, regional air quality programs, climate change and energy initiatives, and a variety of efforts to plan for and build a sustainable region.

DVRPC updated a regional inventory of municipal natural resource protection tools, which include environmental resource inventories, open space plans, stream corridor protection ordinances, tree protection ordinances, and more. DVRPC also updated its inventory of locally funded open space programs, which are municipal programs that acquire and preserve open space through dedicated taxes and bonds. Two Environmental Resource Inventories (ERIs) were published this

year for Bordentown Township and Moorestown in New Jersey, which document each township's climate, soils, streams, wetlands, floodplains, air and water quality, wildlife, natural vegetation, and historical resources, highlighting issues such as threatened or endangered species and water quality impairments.

Partnering with the Pennsylvania Horticultural Society, DVRPC secured funding from PennVest to plant 574 trees in various parks in the City of Chester, and to plant 500 trees in Lake Lenape Park, Sellersville Borough, Bucks County. The new trees will improve stormwater management, water quality, and air quality; reduce flooding; and beautify parks and playgrounds.

DVRPC also provides tips on reducing air pollution through the Air Quality Partnership, which is comprised of over 350 public and private organizations. Two Partnership members, Princeton University and Millbourne Borough, received the 2013 Air Quality Excellence Awards for their sustainability efforts. DVRPC provides daily air quality forecasts and sends out alerts when the air quality is forecast to be unhealthy, encouraging people to limit strenuous outdoor activity. leader on the issues of climate change and infrastructure sustainability in our region, DVRPC has led a number of initiatives to ensure that Greater Philadelphia has a bright future. This year, DVRPC's Circuit Rider for Energy Efficiency in Local Government Operations program provided direct technical assistance to nine Pennsylvania municipalities, working with them to evaluate current energy use, analyze opportunities for energy savings, and share energy management best practices. The program also held two seminars, titled "Strategies to Save Money and Energy in Street Lighting: A Roundtable with DVRPC and PECO" and "Outdoor Area Lighting Best Practices in Southeastern Pennsylvania."

In addition to the Circuit Rider program, the Commission updated its 2005 Energy Use and Greenhouse Gas Emissions Inventory with 2010 data and created a map-based web app that provides users with a custom energy use and GHG emissions profile for each municipality. The Commission's Alternative Energy Ordinance Working Group (AEOWG) developed frameworks to provide guidance to municipalities on how to construct renewable energy ordinances that are consistent with state laws and are effective for solar, geothermal, and wind technologies.

DVRPC also worked with regional stakeholders to create *Ready to Roll!*Southeastern Pennsylvania's Regional

Electric Vehicle Action Plan, a comprehensive, regionally coordinated approach to introducing electric vehicles and electric vehicle supply equipment into southeastern Pennsylvania. In addition, DVRPC launched the Pennsylvania Partnership to Promote Natural Gas Vehicles (P3NGV), which will assist municipalities and school districts in making informed decisions about adopting natural gas vehicles into their municipal waste hauling and school bus fleets.

VRPC is the leading source of regional information, providing a wealth of demographic and economic data, traffic counts, aerial images, and more to stakeholders and the interested public.

As information becomes available, planners analyze data from the U.S. Census Bureau and make it accessible to the public through data bulletins, analytical reports, and the DVRPC website. Population and employment forecasts for 2040 were released last year, as well as information on residential building permits and county-to-county commuting patterns. A series of data snapshots looked at immigration in the region, focusing on municipalities that have a high number of foreign-born residents.

Traffic counts are available online using a user-friendly mapping application. Users can find data that represents the "Annual Average Daily Traffic (AADT)," or a statistically factored volume of traffic in a 24-hour period in the year the count was taken. GLOUCESTER COUNTY'S GAIN

BY 2040, GLOUCESTER COUNTY IS EXPECTED TO GAIN THE GREATEST PERCENTAGE OF JOBS (30.5%) IN THE DVRPC REGION. POPULATION AND EMPLOYMENT FORECASTS ARE A CRITICAL COMPONENT OF LONG-RANGE LAND USE AND TRANSPORTATION PLANNING. VARIOUS STUDIES HAVE SHOWN THAT THERE IS A DIRECT RELATIONSHIP BETWEEN THE NUMBER OF JOBS AND RESIDENTS IN A REGION, AND THAT THE RATIO OF EMPLOYMENT TO POPULATION REMAINS RELATIVELY CONSTANT OVER TIME. THE EMPLOYMENT FORECASTS WERE DEVELOPED BY APPLYING A JOBS-TO-POPULATION RATIO TO DVRPC'S 2040 POPULATION FORECASTS, AND THEN ADJUSTED BASED ON INPUT FROM THE REGION'S CITY AND COUNTY PLANNING STAFFS.

he goal of DVRPC's public outreach is to promote a dialogue between stakeholders and the Commission, and to enhance the awareness of public issues. Last year, DVRPC held a number of public events throughout the region that focused on freight planning in Greater Philadelphia, the Camden County Bicycle and Multi-Use Trails Master Plan, and the update to *Connections 2040*, DVRPC's long-range plan.

As another venue for stakeholder collaboration, DVRPC launched the Public Participation Task Force (PPTF) in November 2012. The PPTF strives to represent the racial, ethnic, cultural, and income diversity of the region, with a member from each county serving for

two years. Members were educated about DVRPC's mission and work, and then recommended the development of a general online public commenting feature, which was subsequently implemented. The PPTF also provided feedback on the *Connections 2040* education and outreach campaign, and discussed how members could help DVRPC spread the message to a wider audience.

The fair treatment and meaningful involvement of all people when planning communities, known as environmental justice (EJ), is integral to DVRPC's work. The FY12 update to the *Environmental Justice at DVRPC* publication detailed each project in which potentially disadvantaged populations were affected. The Commission's

Environmental Justice Work Group also hosted an event titled "Placemaking in Latino Communities," in order to open a dialogue on planning in a multi-ethnic region.

The EJ Work Group also reviewed the draft long-range plan prior to its adoption.

VRPCs committees advise the Board on specific regional issues while ensuring that interested parties, including member governments and concerned citizens, have an opportunity to participate in the planning process. Meeting dates are shown on our website at WWW.DVRPC.ORG. Anyone who wishes may attend any of the following committee meetings:

Regional Technical Committee (RTC)

Advises the Board on issues concerning the long-range and short-range transportation plan, the Transportation Improvement Program, and other programs and policies. *Meets monthly*.

Regional Aviation Committee (RAC)

Conducts aviation system planning activities by providing technical and policy guidance to the Federal Aviation Administration, the states, and the DVRPC planning program. *Meets quarterly*.

Goods Movement Task Force (GMTF)

Works to maximize goods movement capability by sharing information and technology with public and private freight interests. Also promotes the region's intermodal capabilities and implements a regional goods movement strategy. *Meets quarterly*.

Regional Community and Economic Development Forum


Provides a forum for discussion of current issues in land use, housing, economic development, and transportation in the Delaware Valley region. *Meets quarterly*.

Information Resource Exchange Group (IREG)

Provides a forum for the exchange of ideas and experiences among regional data managers. Topics of discussion include IT architecture, GIS/orthophotography, web technologies, and census data. *Meets quarterly*.

Transportation Operations Task Force

Provides a forum for the Incident Management Task Force to share ideas. Topics of discussion may include RIMIS and regional ITS architecture. *Meets quarterly*.



Regional Safety Task Force

Offers guidance to DVRPC projects including the Regional Safety Action Plan and provides a forum for multi-disciplinary professionals to share information.


Public Participation Task Force


