Chapter 7: Programs

DVRPC Regional Highway and Transit Programs

The Draft DVRPC FFY2026 TIP for New Jersey categorizes projects into the following programs: DVRPC FHWA-Funded Program, DVRPC FTA-Funded Program displayed for information purposes, and the Study and Development Program. Additionally, the Statewide Program is included in this document.

The DVRPC region's FHWA-funded and FTA-funded programs include 155 projects that are funded in the TIP over the First-Four Years (FFY26–FFY29). These projects total \$2.299 billion for the phases to be advanced over the next four years, averaging almost \$575 million per year. The project listings within the FHWA-funded and FTA-funded programs that follow this chapter are grouped by county and transit operator/agency. Included are FHWA-Funded projects for Burlington, Camden, Gloucester, and Mercer counties; a listing of projects that apply to various counties; and FTA-Funded projects for NJ TRANSIT and DRPA/PATCO. Within each county grouping, individual FHWA-funded and FTA-funded projects are listed alphabetically by project name.

The DVRPC Regional FHWA-Funded Program contains 98 projects. Programmed funds include \$1.471 billion over the next four years for projects primarily addressing the highway system.

The DVRPC Regional FTA-Funded Program contains 57 projects (37 by NJ TRANSIT and 20 by the DRPA/PATCO) that are primarily programs or reserve line items. Programmed funds include nearly \$1 billion over the next four years for projects addressing the regional FTA-funded system by NJ TRANSIT (about \$886 million) and the DRPA/PATCO (\$114 million).

Statewide Program

The TIP lists 108 NJDOT-managed programs that are for the entire State of New Jersey and worth \$5.3 billion in the First-Four Years. The Statewide Program is primarily state funded over the First-Four Years. The remaining portion of the Statewide Program is federally funded. These Statewide Highway projects/line items are not specific to any particular MPO region but would benefit all or provide direct support to NJDOT.
